Over the years, the multiple occupancy of the main house was allowed to lapse. There is a tenant in the carriage house. The owners want to restore one additional dwelling unit in the main house-making a total of 3 dwelling units on the property. A petition was submitted with signatures of 30 neighbors in support of the requested variance. No one opposed the request at the community meeting, and all 6 committee members in attendance voted to support the variance request.
