Eleven near neighbors attended the RCO meeting. The WMAN Zoning Committee and the voting near neighbors all voted to support the <a href="existing">existing</a> 4 family use of the property. It should be noted this is an application to legalize a use that existed in the property for a number of years according to statements of attendees. One WMAN Zoning Committee member's support was conditioned on the Department of Licenses and Inspections determination that use of the basement complied with building and fire code requirements pertaining to windows. All West Mt. Airy Neighbors Zoning Committee members voted to <a href="mailto:oppose the proposed visitor accommodation">oppose the proposed visitor accommodation</a> use of the basement apartment as did most neighbor attendees.

If the Board is not able to limit its approval solely to the requested 4-unit multifamily use, it is recommended that the Variance request be denied.
